OPINION AND FINDINGS

BY THE COMMISSION:

By applications filed February 22, 1988, James Beeson, dba Hollywood Calling, Cloverdale, California, seeks authority to connect ten automatic dialing-announcing devices in the state of Nebraska.

Applicant is a partnership whose mailing address is 60 Industrial Drive, Cloverdale, California. Applicant proposes to connect ten Advanced Communications automatic dialing-announcing devices.

Applicant has agreed to include on all calls made on the automatic dialing-announcing devices a statement of the nature of the call and the name, address and telephone number of the business or organization being represented. The Commission encourages the applicant to provide a local in-state telephone number whereby the consumer may contact the applicant.

Having reviewed the applications, the Commission finds that the applications do comply with the applicable statutes and Rules and Regulations of the Commission.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application Nos. AD-127, AD-128, AD-129, AD-130, AD-131, AD-132, AD-133, AD-134, AD-135, and AD-136 be and are hereby granted and Hollywood Calling be and it is hereby authorized to connect automatic dialing-announcing devices in accordance with its applications, the Nebraska Statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's Official Permit as hereinbefore set forth.

IT IS FURTHER ORDERED that upon receipt of this permit and prior to connecting the devices to any telephone line, the applicant shall file a copy of its applications and this permit with the serving telephone company.
