IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. AD-296 be, and it is hereby, granted and Above & Beyond Cleaning Services, Inc., be and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska statutes and the Rules and Regulations of this Commission. The message shall contain the name, address and telephone number of the business or organization represented and be transmitted on all calls made with the automatic dialing-announcing device.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official permit as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.


