O P I N I O N A N D F I N D I N G S

By application filed on February 28, 2005, Linebarger, Goggan, Blair and Sampson, LLP (Applicant), Dallas, Texas, seeks authority to connect an automatic dialing-announcing device.

Applicant is a limited liability partnership whose mailing address is 2323 Bryan Street, Suite 1600, Dallas, Texas 75201. Applicant proposes to connect an ADAD unit using Intel Dialogic Cards and Oracle Dialing Software. This unit has the registration number HP003786, KW011782, HQ003697, FCC# EBZUSA-20078-XD-N.

Applicant intends to connect an automatic dialing-announcing device at four locations, accordingly, pursuant to Neb. Admin. Code Title 291, Chapter 11, Rule 002.01, the Commission will give Applicant four registration numbers. The above-captioned registration number will permit Applicant to connect an automatic dialing-announcing device at 900 Arion Parkway, Suite 104, San Antonio, Texas, 78216.

The petition states the Applicant will include on all calls made on the automatic dialing-announcing device, a statement of the nature of the call and the name, address and telephone number of the business or organization being represented.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application AD-330r be, and it is hereby, granted and Linebarger, Goggan, Blair and Sampson, LLP, Dallas, Texas, be and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official permit as set forth in this order and shall remain in force and effect for two years from March 22, 2005, unless used in a manner inconsistent with state or federal law.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.
