By application filed on January 5, 2006, CT Livestock Freight (Applicant), Omaha, seeks authority to connect an automatic dialing-announcing device.

Applicant is a corporation whose mailing address is 2809 S. 160 St., Suite 309, Omaha, NE 68130. Applicant states it will use a Kolker autodialer device, Model SR-DVR-1500, at its Omaha location.

The petition states the Applicant will include on all calls made on the automatic dialing-announcing device, a statement of the nature of the call and the name, address and telephone number of the business or organization being represented.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application AD-334r be, and it is hereby, granted and CT Livestock Freight, Omaha, be and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official permit as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.
