By application filed on January 20, 2006, United Recovery Systems, LP, (Applicant), Houston, Texas, seeks authority to connect an automatic dialing-announcing device.

Applicant is a limited liability partnership whose mailing address is 5800 North Course Drive, Houston, Texas 77072. Applicant states it will use an Interactive Intelligence autodialer device, Customer Interaction Center 2.2 SR-C Model at its Houston location.

The petition states the Applicant will include on all calls made on the automatic dialing-announcing device, a statement of the nature of the call and the name, address and telephone number of the business or organization being represented.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application AD-335r be, and it is hereby, granted and United Recovery Systems, LP, Houston, be and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.
