By application filed on March 29, 2006, Sound Bite Communications, Inc., (Applicant), Burlington, Massachusetts, seeks authority to connect an automatic dialing-announcing device.

Applicant is a Delaware corporation whose mailing address is 2 Burlington Woods Dr., Burlington, Massachusetts, 01803. Applicant states it will use an NMS auto dialer device, Model No. 80298, at its Burlington, Massachusetts, location.

The petition states the Applicant will include on all calls made on the automatic dialing-announcing device, a statement of the nature of the call and the name, address and telephone number of the business or organization being represented.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application AD-340r be, and it is hereby, granted and Sound Bite Communications, Inc., Burlington, Massachusetts, be and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska statutes and the Rules and Regulations of this Commission.

in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.


