By application filed on September 6, 2007, AllianceOne Receivables Management, Inc., (Applicant), Mendota Heights, Minnesota, seeks authority to register and connect an automatic dialing-announcing device to a telephone line.

Applicant is a corporation, incorporated in the State of Delaware, whose mailing address is 1160 Centre Pointe Drive, Mendota Heights, Minnesota. Applicant proposes to connect an Ontario Systems Model GC Hardware - Dialer Rev 02 automatic dialing-announcing device located in Trevoze, Pennsylvania.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.
