O P I N I O N   A N D   F I N D I N G S

On July 21, 2004, Qwest Communications (Qwest) of Denver, Colorado, filed an application seeking approval of its Commercial Line-Sharing Amendment to the Interconnection Agreement with DIECA Communications, Inc. d/b/a Covad Communications Company (Covad), Denver, Colorado, previously granted in Docket No. C-2325. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 21, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On August 1, 2000, pursuant to Application No. C-2325, the original interconnection agreement between Qwest and Covad was approved by this Commission. Subsequent to the original filing, the Commission approved amendments to the agreement in Application Nos. C-2685, C-2790, C-2792, C-2889, C-2928, C-2988, C-3068, and C-3173. In the current application, Qwest seeks to amend the agreement by adding terms and conditions. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed July 21, 2004, should be approved.
