O P I N I O N A N D F I N D I N G S

This matter comes before the Commission upon the filing of an application of Qwest Corporation (Qwest), on September 17, 2004 to update its Exhibit B to the Statement of Generally Available Terms and Conditions (SGAT). Qwest also submits its revised Qwest Performance Assurance Plan (QPAP) found in Exhibit K of the SGAT for modifications to reflect changes from both the June 30, 2004 filing of an updated Exhibit B that took effect pursuant to 47 U.S.C. Section 252(f)(3) sixty days later.

Qwest submits the current filing reflects the resolution of disputed issues in the State of Washington in Docket UT-043007 and attached its stipulation reached with participating CLECs in that state. Qwest requests approval of these changes pursuant to the stipulation referenced. Qwest states the stipulation covers items that were at issue in the Washington six month review which include: standards for line splitting, loop splitting reporting, xDSL-1 capable loops, an aggregate payment report, and the PO-20 PID.

Notice of Qwest's filing was published in the Daily Record, Omaha, Nebraska, on October 20, 2004. No party filed a protest or intervention in this proceeding; accordingly, the Commission processes this application pursuant to its Rule of Modified Procedure.

On March 19, 2002, the Commission entered an order in Commission Application No. C-2666, approving Qwest's revised SGAT, filed on January 25, 2002. On February 4, 2003, in Application No. C-2750, the Commission entered an order approving Qwest's Sixth Revised SGAT. Subsequently, on January 13, 2004, in Application No. C-3029, the Commission entered an order approving Qwest's First Amendment to its Sixth Revised SGAT. Since that time, the Commission has permitted other amendments and revisions to go into effect in docket numbers C-3176, C-3202 and C-3232.

Upon consideration of the current application, the Commission is of the opinion and finds the proposed SGAT revisions should be declared effective.


O R D E R


