O P I N I O N   A N D   F I N D I N G S

On December 3, 2004, Qwest Corporation (Qwest) of Denver, Colorado, filed an application seeking approval of its Special Promotion Amendment for Available Inventory Collection Sites with Cox Nebraska Telecom, LLC, previously approved in Application Number C-1473. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 7, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On July 1, 1997, pursuant to Application C-1473, the original interconnection agreement between Qwest Corporation and Cox Nebraska Telecom, LLC was approved by this Commission. In the current application, Qwest seeks to amend the agreement by adding a special promotion amendment for available inventory collection sites. An executed copy of the interim amendment is contained within the application.

~~The amendment does not discriminate against any telecommu-  
nications carrier. Furthermore, the implementation of the amendment  
is consistent with the public interest, convenience and necessity.~~

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed December 3, 2004, should be approved.
