O P I N I O N A N D F I N D I N G S

On November 28, 2005, an application was filed by Qwest Corporation (Qwest), Denver, Colorado, seeking approval of an amendment to its interconnection agreement with Global Connection, Inc. of America d/b/a GCIA (Global), Atlanta, Georgia. The interconnection agreement Qwest and Global seek to amend was previously approved in Application No. C-3311. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 5, 2005. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and Global entered into an interconnection agreement, which was approved by the Commission on January 11, 2005, in Application C-3311. In the current application, Qwest and Global seek to once again amend their agreement. Executed copies of the amendment are contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the amendment filed November 28, 2005, should be approved.
