O P I N I O N A N D F I N D I N G S

On January 17, 2006, an application was filed by Qwest Corporation (Qwest) of Denver, Colorado, seeking approval of an amendment to incorporate the Triennial Review Order and the Triennial Review Remand Order into the interconnection with SBC Long Distance, Inc. fka Southwestern Bell Communications Services (SBC), of Dallas, Texas. The original agreement was previously approved in Application No. C-3284. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 6, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and SBC entered into an interconnection agreement, which was approved by the Commission on December 1, 2004 in Application No. C-3284. In the current application, Qwest and SBC seek to amend the original agreement by incorporating the Triennial Review Order and the Triennial Review Remand Order.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed January 17, 2006, should be approved.
