By application filed February 3, 2006, Qwest Corporation ("Qwest") of Denver, Colorado, seeks approval of an amendment to the wireline interconnection agreement with DIECA Communications d/b/a Covad Communications Company ("Covad") of San Jose, California. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 10, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and Covad entered into an interconnection agreement, which was approved by the Commission on March 7, 2006 in Application No. C-3351. In the current application, Qwest, and Covad seek to amend their agreement. Executed copies of the amendment are contained within the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed should be approved.
