BY THE COMMISSION:

On March 17, 2006, an application was filed with the Public Service Commission (Commission) by Qwest Corporation, Denver, Colorado, (Qwest) seeking arbitration and approval of an interconnection agreement with Total Telepage, North Platte; Heartland Communications, Crystal Lake, Illinois; Midland Telecom, Inc. d/b/a KHN Communications, Grand Island; Mid Nebraska Telephone aka Mid Neb Telecom, Grand Island; and Priority Paging, Key Biscayne, Florida (Respondents).

On April 7, 2006, Qwest filed a motion to extend the deadline to select an arbitrator, as Commission policy sets the deadline for the parties to choose an arbitrator fifteen (15) days after receipt of the application by the Commission, or April 7, 2006. In an order dated April 11, 2006, the Commission granted Qwest's motion for extension of the deadline and set the new deadline for the parties to choose an arbitrator of May 9, 2006. None of the Respondents filed a response to Qwest's application for arbitration or the Commission's April 11, 2006 order.

On June 14, 2006, Qwest filed a motion to dismiss all Respondents and close the docket. Qwest states that Total Telepage, Priority Paging and Midland Telecom have all executed interconnection agreements with Qwest pursuant to 47 USC § 252(b). Mid Nebraska Telephone has disconnected its services for which Qwest had requested the interconnection agreement, rendering the need for the agreement moot. Finally, Heartland Communications, Inc.'s assets and billing numbers have been acquired by Electronic Engineering, a separate company with whom Qwest has an interconnection agreement on file with the Commission.

O R D E R



IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3571 be and is hereby dismissed.
