BY THE COMMISSION:

By application filed May 26, 2006, Qwest Corporation (Qwest), Denver, Colorado, seeks approval of its cageless physical collocation amendment to the interconnection service agreement with Cox Nebraska Telecom, LLC, (Cox), Omaha, Nebraska. Notice of the application was published in the Daily Record, Omaha, Nebraska, on June 16, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and Cox entered into an interconnection service agreement arrived at through voluntary negotiations which was approved by the Commission in Application No. C-1473 on November 18, 1997. In the current application, Qwest and Cox seek to amend the original agreement. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the interconnection agreement should be approved.
