O P I N I O N   A N D   F I N D I N G S

On August 1, 2006, Qwest Corporation (Qwest), of Denver, Colorado, filed an application seeking approval of its Triennial Review Order and Triennial Review Remand Order Amendment to the interconnection agreement with Community Internet Systems (Community Internet), Inc., of Columbus, Nebraska. The original interconnection agreement between Qwest and Community Internet was previously approved by the Commission in Application No. C-2702. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 3, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On April 23, 2002, in Application No. C-2702, this Commission approved the original interconnection agreement between Qwest and Community Internet. In the current application, Qwest seeks to amend the agreement by adding a Triennial Review Order and Triennial Review Remand Order Amendment to the interconnection agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the amendment filed August 1, 2006, should be approved.
