On October 17, 2006, Qwest Corporation (Qwest) Denver, Colorado, filed an application seeking approval of its special promotion for available inventory collocation sites Amendment to the interconnection agreement with Dieca Communications Inc. d/b/a Covad Communications Company, (Dieca) Denver, Colorado, previously granted in Docket No. C-3351. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 23, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On March 7, 2006, in Application No. C-3357, the original interconnection agreement between Qwest and Dieca was approved by this Commission. In the current application, Qwest seeks to amend the agreement by adding a special promotion for available inventory collocation sites Amendment to the interconnection agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as
