BY THE COMMISSION:

On November 7, 2006, an application was filed by Northeast Nebraska Telephone Company, Jackson, seeking approval of an Interconnection and Reciprocal Compensation Agreement between Aventure Communications Technology, L.L.C. (Aventure), Sioux City, Iowa. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 15, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the Telecommunications Act of 1996 (the Act), Northeast Nebraska Telephone Company and Aventure entered into an interconnection agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the interconnection and reciprocal compensation agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection and Reciprocal Compensation Agreement between Northeast Nebraska Telephone Company and Aventure be, and it is hereby, approved.
