BY THE COMMISSION:

By application filed November 29, 2007, United Telephone Company of the West d/b/a Embarq (Embarq) of Overland Park, Kansas, and BullsEye Telecom, Inc., (BullsEye) of Oak Park, Michigan seek approval of their Interconnection, Collocation and Resale Agreement. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 3, 2007. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Embarq and BullsEye entered into an Interconnection, Collocation and Resale Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Interconnection Agreement should be approved.
