On May 12, 2008, Qwest Corporation (Qwest), Denver, Colorado, filed an application seeking approval of its Triennial Review Order and Triennial Review Remand Order Amendment to the Interconnection Agreement with Houlton Enterprises, Inc. dba Guaranteed Phone Service (Guaranteed Phone Service), Council Bluffs, Iowa, which was previously approved in Docket C-2917. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 16, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On May 20, 2003, in Application C-2917, the original interconnection agreement between Qwest and Guaranteed Phone Service was approved by this Commission. In the current application, Qwest seeks to amend the agreement by adding a Triennial Review Order and Triennial Review Remand Order Amendment to the Interconnection Agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

O R D E R


