O P I N I O N A N D F I N D I N G S

On October 14, 2008, Qwest Corporation ("Qwest") of Denver, Colorado, filed an application seeking approval of its Triennial Review Order and Triennial Review Remand Order (TRO/TRRO) Amendment with McLeodUSA Telecommunications Services, Inc., (McLeod), of Hiawatha, Iowa. The agreement amends the Interconnection Agreement previously approved in Docket C-2023. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 16, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On April 14, 1999, in Docket C-2023, the original interconnection agreement between Qwest and McLeod was approved by the Commission. In the current application, Qwest seeks to amend the agreement by adding a Triennial Review Order and Triennial Review Remand Order Amendment to the Interconnection Agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the Amendment filed October 14, 2008, should be approved.


