BY THE COMMISSION:

By application filed August 29, 2005, Telephone Company, Central Florida, Inc. (TCCF) a/k/a Epicus, Inc. (Epicus), Lake Mary, Florida, seeks cancellation of its authority to operate as a resale carrier of intrastate interLATA and intraLATA telecommunications within the state of Nebraska, granted in Docket No. C-1720. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 30, 2005. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

On February 18, 1998, TCCF was granted a certificate to operate as a resale carrier within the state of Nebraska, pursuant to Application C-1720.

By letter received on August 29, 2005, TCCF requested the withdrawal of its certificate of authority issued by the Commission in Application C-1720. TCCF ceased provisioning resold long distance services within the state of Nebraska on June 9, 2005.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that TCCF's certificate of authority previously granted in Application C-1720 should be canceled.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-3472 be, and it is hereby, granted and the certificate of authority previously granted to Telephone Company, Central Florida, Inc., a/k/a Epicus, Inc. in Application C-1720 is canceled.
