On September 27, 2004, an application was filed by VCI Company, d/b/a Vilaire Communications Inc. seeking a Certificate of Public Convenience and Necessity as a local competitive exchange carrier pursuant to Neb. Rev. Stat. Section 86-128 and seeking designation as an eligible telecommunications carrier. Formal Interventions were timely filed by Benkelman Telephone Company, Inc, Arapahoe Telephone Company d/b/a ATC Communications, Cozad Telephone Company, Curtis Telephone Company, Diller Telephone Company, Glenwood Telephone Member Corporation, Keystone-Arthur Telephone Company, Plainview Telephone Company, Wauneta Telephone Company, Hartman Telephone Exchanges, Inc., Mainstay Communications and Hooper Telephone Company d/b/a WestTel Systems.

In order to process the eligible telecommunications carrier designation portion of the application, the Commission held a planning conference in this matter on January 14, 2005, at the Commission, 300 The Atrium, 1200 N Street, Lincoln, Nebraska and via telephone conference with the Interveners and the Applicant. The following persons were either present or participated via telephone bridge during the planning conference: Stan Efferding of Vilaire Communications, Inc., Timothy F. Clare of Remboldt Ludtke, LLP and James Overcash of Woods & Aitken, LLP on behalf of the Interveners, and Shana Knutson on behalf of the Commission.
