BY THE COMMISSION:

On August 5, 2005, Navigator Telecommunications, LLC, (Navigator), North Little Rock, Arkansas, filed an application seeking authority to provide Competitive Local Exchange and Interexchange Telecommunications Services in the state of Nebraska. The application was docketed as C-3466. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 8, 2005.

On October 21, 2005, Navigator filed a request to withdraw its application. The request to withdraw was docketed as C-3496. Standard Commission procedure is to not assign a new docket number to requests to voluntarily withdraw an application; however, in this case a new docket number was issued. Notice of the withdrawal request was published in The Daily Record, Omaha, Nebraska, on October 26, 2005. No protests were filed under either docket.

Upon consideration of Navigator's request to withdraw the application, the Commission is of the opinion and finds said request should be granted. The application filed in docket C-3466 is withdrawn at Applicant's request.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request to withdraw docketed in C-3496 be, and it is hereby, granted, and Application C-3466 is hereby withdrawn at Applicant's request.
