BY THE COMMISSION:

By its application filed October 25, 2006, Neutral Tandem-Nebraska, LLC, (Applicant or Neutral), Chicago, Illinois, seeks authority to operate as a facilities-based and resale local exchange carrier and interexchange carrier of telecommunications services within the State of Nebraska. Notice of the application was published in the Daily Record, Omaha, Nebraska, on October 30, 2006. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N S A N D F I N D I N G S

Applicant is a wholly owned subsidiary of Neutral Tandem, Inc., (Parent). Applicant is a privately held limited liability company organized under Delaware law and is authorized to transact business in the State of Nebraska. There is a separate limited liability company set up for each of Parent's subsidiaries by state. Applicant's affiliates have been authorized to provide local and interexchange services in California, Colorado, Florida, Georgia, Illinois (also serving Wisconsin), Indiana, Maryland, Michigan (also serving Ohio), Minnesota, Missouri, Nevada, New Jersey, New York (also serving Connecticut and Pennsylvania), Oregon, Virginia, Washington, and the District of Columbia. Neither Applicant nor its domestic member shareholders have been the subject of any formal complaints or other investigatory proceedings.

Applicant seeks authority to provide both facilities-based and resold local exchange and interexchange

telecommunication services in the State of Nebraska in the service territories of Qwest Corporation. Applicant plans to provide services primarily over their own facilities using a Nortel DMS switch and lease fiber optic facilities. Where Applicant otherwise lacks facilities and where customer demand warrants, Applicant may resell the high capacity special access services, such as DS-1 and DS-3, and multiplexing services, of other facilities-based carriers. Neutral maintains a network operations center that is staffed 24 hours a day. Applicant has a toll-free number for billing and customer service related issues.

Applicant will provide both facilities based and resold non-switched dedicated and private line services that will provide ILECs, CLECs, ISPs, paging and cellular companies, cable companies, and government and corporate customers with broadband transmission services throughout Nebraska to the extent authorized by the Commission. Services will be provided 24 hours a day, seven days a week.

Applicant will not be marketing to residential or small businesses, but primarily to other carriers. Applicant's initial service offering will consist of transport and access services for competitive carriers. Neutral has no plans to provide dial tone services to end user customers at this time. We find that the Applicant shall inform the Commission if and when they begin offering dialtone or voice grade services to end users. Further, the Applicant shall and has agreed to comply with all state and federal rules and regulations governing the provisions of dialtone or voice grade service, if and when Neutral begins offering such services.

Confidentially filed Exhibit E to the application is a copy of Parent's financial statements and Applicant's financial statements for its last three years of operation, 2003, 2004, and 2005, and an interim statement for 2006.

Applicant has no plans to provide local exchange services to areas served by an incumbent local exchange carrier in Nebraska that is eligible for a small or rural carrier exemption pursuant to Section 251(f)(1) of the Federal Act. Applicant does not seek to provide service to customers in those small or rural territories.

Applicant states it possesses the necessary expertise and management team to serve its Nebraska customers. In Exhibit D, filed with the Applicant's application, Applicant provided profiles of its key executive and technical management.

Applicant states a grant of this application will serve the public interest because Applicant is a leader in the development and provisioning of high quality telecommunications services. Consumers of telecommunications services in Nebraska will benefit with the increase in the diversity of suppliers and competition within the local exchange and interexchange telecommunications market.

The Commission considers this application for authority in light of the following criteria and standards established in the Commission's telecommunications rules:

- (a) Whether the Applicant has provided the information required by the Commission;
- (b) Whether the Applicant has provided a performance bond, if required;
- (c) Whether the Applicant possesses adequate financial resources to provide the proposed service;
- (d) Whether the Applicant possesses adequate technical competence and resources to provide the proposed service;
- (e) Whether the Applicant possesses adequate managerial competence to provide the proposed service; and
- (f) Whether granting the Applicant a certificate preserves and advances universal service, protects the public safety and welfare, ensures the continued quality of telecommunications services and safeguards the rights of consumers, pursuant to Section 253(b) of the Act.

Applicant has demonstrated that it meets the standards of financial, technical, and managerial competence and all other criteria necessary to provide interexchange services

in the State of Nebraska and local exchange services in the proposed territories.

These opinions and findings carry no precedential value other than establishing minimum standards and criteria to apply when considering applications to provide interexchange and local exchange services in the above-mentioned territories. All telecommunications carriers seeking such a certificate must demonstrate that they meet, at a minimum, the standards and criteria set forth herein.

Before the Applicant is allowed to provide local exchange service to its users, it must either:

1. Through negotiation or arbitration, reach an interconnection/resale agreement with the pertinent incumbent local exchange carrier and receive Commission approval of the interconnection/resale agreement; or
2. In the event a certified local exchange carrier provides a wholesale tariff, purchase rates from that tariff, file its own tariff and receive Commission approval of its tariff.

This order does not terminate, waive or in any manner diminish the exemptions and protections created by the Act for rural carriers, as defined by the Act. This order does not address the issue of the rural local exchange carrier exemption under the Act. Rural exemptions may be terminated, suspended or modified only as provided in Section 251(f) of the Act.

Prior to providing local exchange service in any area in the State of Nebraska, Applicant must file tariffs in accordance with the provisions of Section 002.21 of the Neb. Admin. R. & Regs. Title 291, ch. 5.

As a provider of interexchange and local exchange services in the state of Nebraska, Applicant would be subject to the same laws, rules and regulations, both federal and state (including any laws, rules or regulations regarding universal service, restrictions on joint marketing and quality of service), applicable to any other local exchange company except those obligations imposed on ILECs pursuant to Section 251(c) of the Act.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3713 be, and hereby is, granted.

IT IS FURTHER ORDERED that Applicant is obligated to abide by the same laws, rules and regulations, both federal and state (including any laws, rules or regulations regarding universal service, restrictions on joint marketing and quality of service), applicable to any other interexchange and local exchange carriers, except obligations imposed on incumbent local exchange carriers pursuant to Section 251(c) of the Act.

IT IS FURTHER ORDERED that, to the extent Applicant provides access line service as referenced in the Telecommunications Relay System Act, Neb. Rev. Stat. §§ 86-301 through 86-315 (Relay Act) and defined in Neb. Admin. R. & Reg. Title 291, ch. 5 § 001.01B, the Applicant shall collect from its subscribers a surcharge (Relay Surcharge) pursuant to the relay act and the Commission's annual orders establishing the amount of the surcharge, and shall remit to the Commission the proceeds from the relay surcharge as provided by the Relay Act.

IT IS FURTHER ORDERED that the Applicant comply with all necessary statutes and Commission Rules and Regulations as they pertain to the Nebraska Universal Service Fund.

IT IS FURTHER ORDERED that Applicant shall file, in accordance with the applicable statutes, on or before April 30 of each year, an annual report with the Commission consisting of: (a) a copy of any report filed with the Federal Communications Commission; (b) a copy of any annual report to stockholders; and (c) a copy of the latest Form 10-K filed with the Securities and Exchange Commission. If such reports are unavailable, Applicant shall file a balance sheet and income statement for the previous year of operation, and for the State of Nebraska on a combined interstate-intrastate basis, the investment in the telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, operating expenses and taxes.

IT IS FURTHER ORDERED that within 30 days from the entry of this order that the Applicant file a tariff and

pay appropriate filing fees with the Commission as required by state statutes and the Commission's regulations.

IT IS FURTHER ORDERED that the Applicant notify the Commission if and when they begin offering voice grade or dialtone service in Nebraska and upon the offering of such service Applicant shall comply with all rules and regulations governing the provisions of dialtone or voice grade service.

IT IS FINALLY ORDERED that this order be, and hereby is, made the Commission's official Certificate of Public Convenience and Necessity to the Applicant to provide facilities-based and resold interexchange and local exchange telecommunications services in the State of Nebraska.
