BY THE COMMISSION:

On September 2, 1998, Arapahoe Telephone Company dba ATC Communications (ATC) of Arapahoe, Nebraska, filed an application to revise the boundary between its Arapahoe exchange and the Edison exchange served by GTE Midwest, Inc. (GTE). Notice of the application was published in the The Daily Record, Omaha, Nebraska, on September 4, 1998, pursuant to the Commission's Rules.

O P I N I O N   A N D   F I N D I N G S

ATC and GTE are local exchange carriers operating in Nebraska and are subject to the Commission's general regulation of common carriers. Nebraska statutes establish if the telephone company or companies affected by proposed boundary revisions do not object to the application, the application may be processed by modified procedure. By letter dated August 11, 1998, GTE informed ATC that it concurred with its proposed boundary change. A copy of said letter was included with the application and was marked as Exhibit A. Since no protests were filed, the Commission will process the application pursuant to its rule of modified procedure.

The applicant attached a map showing the proposed placement of the boundary between the Edison and Arapahoe exchanges which was marked as Exhibit B. That map is attached hereto and made a part of this order. At the present time there are no subscribers located in the area to be transferred.

Upon consideration of the application and being fully advised, the Commission is of the opinion and finds the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1897 be, and it is hereby, granted.

IT IS FURTHER ORDERED that Arapahoe Telephone Company dba ATC Communications and GTE Midwest, Inc. submit revised boun-






