On June 5, 2001, an application was filed by Aliant Communications Co., d/b/a ALLTEL of Lincoln, Nebraska, seeking authority to change its name to ALLTEL Nebraska, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 7, 2001. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Aliant Midwest is a corporation existing under the laws of the State of Nebraska. The applicant owns a complete telecommunications system operating in 137 exchanges located in southeastern Nebraska providing exchange, interexchange, operator services, toll and all communication facilities and services which are required by its subscribers. The applicant has been issued, and operates pursuant to, one or more certificates of public convenience and necessity to provide telecommunications services in the State of Nebraska. Aliant Communications Co., is a wholly-owned subsidiary of Aliant Communications Inc., d/b/a ALLTEL.

No change in rates, terms or conditions of Aliant Communications Co. provisions of telecommunication services to its customers or any other changes in the aspects of Aliant Communications Co. business activities which are subject to this Commission's jurisdiction will be caused by the proposed name change.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2546 be, and it is hereby, granted and Aliant Communications Co., d/b/a ALLTEL, is authorized to change its name to ALLTEL Nebraska, Inc.

IT IS FURTHER ORDERED that the applicant file an updated tariff reflecting the change in name within 30 days of the date of this order.
