BY THE COMMISSION:

On September 17, 2004, Teligent Services, Inc., (Teligent) of Herndon, Virginia, filed an application seeking authority to transfer control of Nebraska customer assets to Startec Global Licensing Company, (Startec) of Potomac, Maryland, and to cancel Teligent's authorization to provide resale interexchange services in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 20, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

The Parties:

Teligent is a Delaware corporation with its principal place of business located in Herndon, Virginia, and is a wholly-owned subsidiary of Teligent, Inc. This Commission granted authority to Teligent, Inc. to provide local and interexchange telecommunications services in this state pursuant to Application Nos. C-1714 and C-1715. Subsequently, this authority was transferred to Teligent pursuant to Application No. C-2068 because of a corporate restructuring.

Startec is a Delaware corporation with its principal office located in Potomac, Maryland, and is a wholly-owned subsidiary of Startec Global Communications Company. Startec was authorized to provide resold interexchange telecommunications services in this state on pursuant to Application No. C-3258.

Description of the Transaction:

Teligent and Startec request Commission approval for a transaction that will result in transfer of Teligent's Nebraska

long distance customer base, including associated customer account information to Startec. The proposed transaction does not involve the transfer of network facilities or telecommunications equipment in the State of Nebraska. While the transaction will nominally close on November 15, 2004, Teligent and Startec acknowledge that the closing and transfer of control is subject to, and contingent upon, approval of this application by the Commission.

Customers will be given no less than 30 days prior written notice of the proposed transfer, in compliance with the rules of the Federal Communications Commission. Following the transfer, customers will continue to receive services which will be consistent with the quality of services provided by Teligent and which will be supported by Startec's experienced and well-qualified management team. As a result, the proposed transfer will be virtually transparent to the customers in terms of rates, terms and conditions of service.

In the event that a customer elects not to make the change, Applicants will be required by the Commission to ensure that any customer who chooses to do so can transfer to another carrier without interruption of service.

After the transaction has been completed in all states, Teligent will file a subsequent application in Nebraska requesting to surrender its authority to operate as resale carrier of interexchange telecommunications services in Nebraska.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3264 be, and it is hereby, granted.
