BY THE COMMISSION:

By Application filed May 11, 2005, 34 Nebraska Rural Local Exchange Carriers (the "RLECs")¹ requested that the Commission enter an order extending the date by which the RLECs are required to file a petition for further relief as set forth in the Commission's July 20, 2004, Order Granting Suspension in Docket C-3096, et al. and the August 3, 2004, Order Granting Limited Extension in Docket C-3207 (collectively referred to herein as the "Suspension Order").

On July 12, 2005, the Commission entered an Order finding that the date by which the RLECs were required to file a petition or petitions for further relief from the obligations of the *Intermodal Order* should be extended from July 20, 2005, to the "Extension Petition Date"² and that the termination date for the Suspension Order should be extended to the date that is one hundred twenty (120) days following the "Extension Petition Date" in order that the Commission shall have 120 days to act

thereon. The "Extension Petition Date", as a result of the FCC's Order released on November 8, 2007, was December 7, 2007.

On December 7, 2007, the Commission received two supplemental applications for relief filed by the Rural Independent Companies (RIC) and the Rural Telephone Coalition of Nebraska (RTCN) representing a group of rural incumbent local exchange carriers. Not all of the 34 RLECs requested additional relief.

This Progression Order is entered to clarify the deadline for implementing wireline-wireless local number portability as determined by the Commission in its July 20, 2005, Order. The July 20, 2005, Order held that the termination date for the Suspension Order should be extended to the date that is one hundred twenty (120) days following the "Extension Petition Date." In accordance with this finding, the Commission clarifies that **April 5, 2008**, is the date in which the RLECs with no further grant of relief are required to have implemented wireline-wireless local number portability. Should any interested party wish to dispute the calculation of the deadline said interested party should file a motion with the Commission disputing this interpretation on or before February 19, 2008. As to the RLECs who have otherwise preserved their ability to seek an extension of time to implement wireless-wireline number portability, the Commission will consider the requests for supplemental relief in this proceeding.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the implementation date for wireline-wireless number portability be, and it is hereby clarified as provided herein.
