BY THE HEARING OFFICER:

On August 16, 2005, an application was filed with the Public Service Commission (Commission) by Budget Phone, Inc., Shreveport, Louisiana (Budget), seeking designation as an Eligible Telecommunications Carrier (ETC) in the state of Nebraska. A Petition of Formal Intervention was timely filed by the Rural Independent Companies (RIC)¹.

In order to process the application, a planning conference was held in this matter on January 12, 2006, at 10:00 a.m. in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska, and via telephone conference with the representatives of Budget and RIC. The following persons were present at the conference: Lance Steinhardt, counsel for Budget; Jim Overcash, counsel for RIC; and Nichole Underhill, counsel for the Commission.

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.

By end of business on January 24, 2006, the parties will have exchanged with each other and filed with the Commission a final witness list and/or any written witness testimony. Budget agreed to file an amended application in consideration of the Commission's ETC Policy guidelines set out in Docket No. C-3415.

The hearing in Application No. C-3469 will be held on January 31, 2006, at 1:30 p.m. in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska.

Any remaining pre-hearing issues that the parties would like to address should be brought before the Commission prior to hearing.


O R D E R
