BY THE COMMISSION:

On September 27, 2005, an Application was filed by MCI, Inc. (MCI), Ashburn, Virginia, seeking authority to transfer assets of MCI WorldCom Network Services, Inc. (MCI Network Services), Ashburn, Virginia, to MCI WorldCom Communications Services, Inc. (MCI Communications Services), Ashburn, Virginia. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 6, 2005. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

MCI is a Delaware Corporation with its principle office in Ashburn, Virginia. MCI is the ultimate parent company for several certificated telecommunication entities subject to the jurisdiction of the Nebraska Public Service Commission. These subsidiary companies include MCI Network Services and MCI Communications Services

As part of MCI's continued efforts to streamline its corporate structure, MCI Network Services' assets, facilities, and wholesale customer contracts will be transferred to MCI Communications Services. MCI Network Services has no retail customers. The transfer will be seamless and transparent and will not adversely affect the provision of service in Nebraska. All customers served by MCI Network Services facilities will be served by MCI Communications Services after the transfer of assets. No new authority is requested nor required. MCI will retain control over both subsidiaries. There will be no change of ownership of certificates of authority and MCI Network Services is retaining its certificates and not requesting the cancellation of authority at this time.


