BY THE COMMISSION:

On November 21, 2005, The Blair Telephone Company (Blair) and Arlington Telephone Company (Arlington or, jointly, Applicants) both of Blair, filed a joint application seeking to rescind the transfer of authority granted to Blair by the Commission. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 7, 2005. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

The Parties:

Blair and Arlington are Nebraska corporations with their principal offices located in Blair, Nebraska. HunTel Systems, Inc. (HunTel), also a Nebraska corporation, is the sole shareholder of both Blair and Arlington. The Commission approved HunTel's acquisition of control of Blair and Arlington on June 30, 1998, in Application C-1815.

Description of the Transaction:

In March 2005, Applicants anticipated merging Blair and Arlington into a single corporation to be known as The Blair Telephone Company, and filed an application seeking authority from the Commission to consummate the transaction and transfer authority. Applicants now request reversal of the authority that was transferred and granted in Application No. C-3404.

HunTel has entered into an agreement to transfer ownership of both Blair and Arlington effective sometime in early 2006. The expected new owner of the companies does not wish to proceed with the merger of Arlington into Blair.

Applicants contend that granting of this application will serve the public interest, convenience and necessity. We find
