BY THE COMMISSION:

On May 8, 2006, an application was filed by ALLTEL Communications of the Midwest, Inc. ("ALLTEL CLEC") of Lincoln, seeking authority to changes its name to Windstream of the Midwest, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 15, 2006. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

ALLTEL CLEC is a corporation existing under the laws of the state of Nebraska with it principal offices located at 1440 M Street, Lincoln, Nebraska 68508. ALLTEL CLEC provides competitive local exchange service and other communications facilities and services in the state of Nebraska, which are required by its customers. ALLTEL CLEC operates pursuant to a certificate of public convenience and necessity issued by this commission and is subject to the jurisdiction of this Commission. ALLTEL CLEC is a wholly owned subsidiary of ALLTEL Communications Holdings of the Midwest, Inc.

In the present application, ALLTEL CLEC requests that the Commission enter an order approving the adoption by ALLTEL CLEC of the name "Windstream of the Midwest, Inc." in connection with its offering of telecommunications services as a common carrier in the state of Nebraska. ALLTEL CLEC has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms or conditions of ALLTEL CLEC's provision of telecommunications services to its customers, or any other change in ALLTEL CLEC's business activities, which are subject to the jurisdiction of the Commission. Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.



O R D E R
