The Nebraska Public Service Commission (Commission) initiates this proceeding to review and seek public comment on the "Final Report on the Audit of Qwest's Performance Assurance Plans" ("2004 Audit Report") completed by Liberty Consulting. On October 28, 2006, the 2004 Audit Report of the QPAP was completed by Liberty Consulting, a consulting firm chosen by the Regional Oversight Committee (ROC) to oversee the QPAP performance audit for thirteen states in Qwest Corporation's (Qwest's) service territory (collaborative states). The ROC requested Liberty Consulting verify the accuracy of i) 2004 Qwest Performance Assurance Plan (QPAP) payments to competitive local exchange carriers (CLECs) and the states participating in the audit, and ii) the performance results for selected measures.

The Commission seeks comment on the 2004 Audit Report. The public version of the 2004 Audit Report is available on the Commission's website at www.psc.state.ne.us. Any interested person may file comments on the public 2004 Audit Report on or before August 2, 2006.
