BY THE COMMISSION:

On July 3, 2006, an application was filed by Electric Lightwave, LLC ("ELI" or "Applicant"), of Salt Lake City, Utah, seeking to adopt the "doing business as" (d/b/a) name Integra Telecom. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 12, 2006. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

ELI is a limited liability company formed under the laws of the State of Delaware with its principal place of business in Vancouver, Washington. Applicant was granted authority to provide intrastate telecommunications services in Nebraska pursuant to Application No. C-1600. ELI provides integrated full-service telecommunications services.

On May 10, 2006, the Commission approved a transaction whereby ELI will become a wholly-owned subsidiary of Integra Holdings, Inc. (Integra) in Application No. C-3570. In the present application, Applicant seeks authorization to adopt the d/b/a name Integra Telecom. The Applicant states that ELI and Integra are working to better integrate and coordinate ELI's operation with that of Integra. In furtherance of that goal, ELI proposes to adopt the d/b/a name Integra Telecom to more seamlessly promote and market their services and prevent customer confusion.

The d/b/a name will have no impact on customers, services or corporate structure of ELI. ELI customers were notified of the new d/b/a name via written communication on June 30, 2006.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3657 be, and it is hereby, granted and Electric Lightwave, LLC is authorized to adopt the d/b/a name Integra Telecom.

IT IS FURTHER ORDERED that the updated tariff reflecting the change in name be, and it is hereby, approved, and Electric Lightwave, LLC's tariff(s) be appended accordingly.
