BY THE HEARING OFFICER:

On July 9, 2008, Qwest Corporation ("Qwest") filed a Notice of Intent to File Catalog with Increased Switched Access Rates. On July 16, 2008, pursuant to Neb. Rev. Stat. § 86-140 (Cum. Supp. 2006), MCI Communications Services Inc. d/b/a Verizon Business Services ("Verizon") filed a protest and a request for review of Qwest's proposed access rate increase. On July 29, 2008, the Commission entered an order suspending the effective date of Qwest's access rate increase, opening the above-captioned investigation, and setting a deadline to formally intervene of August 11, 2008. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on July 30, 2008.

Petitions for Formal Intervention were timely filed by Verizon, the Rural Independent Companies ("RIC"), AT&T Communications of the Midwest, Inc. and TCG Omaha (collectively "AT&T"), McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services ("PAETEC"), Windstream Nebraska, Inc. ("Windstream"), United Telephone Company of the West, d/b/a Embarq ("United"), the Rural Telecommunications Coalition of Nebraska ("RTCN"), and the Communications Department and Nebraska Telecommunications Infrastructure and Public Safety Department of the Commission (collectively "Commission Staff").

Motion Pro Hac Vice

This matter comes before the Hearing Officer on the motion of Jill Vinjamuri Gettman to admit Timothy J. Goodwin, a nonresident attorney, to practice in Nebraska on behalf of Qwest Corporation, in the above-referenced docket. Mr. Goodwin filed his motion through Ms. Gettman, a resident of Nebraska, who is duly and regularly admitted to practice in the courts of record in this state. Mr. Goodwin is a practicing attorney in good standing for the courts of record in the State of Colorado. Being duly advised of the premises, I find said motion should be granted.

Planning Conference

A planning conference was held on August 21, 2008, at 2:30 p.m. in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska, and via telephone conference. The following parties were present at the conference: for Verizon, Steven G. Seglin of Crosby, Guenzel, LLP; for AT&T, Loel P. Brooks of Brooks, Pansing, Brooks PC LLO; for RTCN, Troy Kirk of Rembolt Ludtke LLP; for RIC and Windstream, James A. Overcash of Woods & Aiken LLP; for United, Deonne Bruning of Deonne Bruning, PC LLO; and for the Commission, Nichole Underhill. Participating via telephone for Qwest, Timothy J. Goodwin of Qwest and Jill Vinjamuri Gettman of Gettman & Mills LLP; for AT&T, Letty S.D. Friesen; for Verizon, Thomas F. Dixon and Neal Larson; for Commission Staff, Shana Knutson.

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.

Agreement to Waive Statutory Timeline

All the parties at the planning conference orally stipulated and agreed to waive the deadline set in Neb. Rev. Stat. § 86-140(1) (Cum. Supp. 2006). Said statute provides that the Commission must conduct a hearing within 90 days of a filing of a request for review of an access charge rate filing. Accordingly, the deadline to hold the hearing would be on or before October 14, 2008. All parties agreed to a procedural schedule in this docket with dates that extend beyond the 90 day statutory requirement to hold the hearing. William A. Haas, counsel for PAETEC, agreed to the extension via electronic mail on August 22, 2008.

Deadlines for various events were established and are set forth in Appendix A.

A Hearing in Application No. C-3945/NUSF-60.02/PI-138 will be held on **October 22, 2008**, at 10:00 a.m. in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. The hearing will be extended to October 23, 2008, as necessary.


IT IS THEREFORE ORDERED by the Hearing Officer that the above-referenced motion to admit a non-resident attorney be and it is hereby granted.
