The Nebraska Public Service Commission (Commission) opened this docket to adopt a relief plan for the 402 area code on March 17, 2009. Comments were filed on April 17, 2009, by interested parties. Comments were filed by: Qwest Corporation, Cox Nebraska Telcom, LLC, the Rural Independent Companies, Sprint Nextel, AT&T, Verizon Wireless, Verizon Business and CTIA. All commenters supported an all-services overlay plan.

On April 20, 2009, the Commission held a workshop to collect information and speak with the industry on the alternative relief plans. All participants again supported an all-services overlay plan. The discussion then focused on the time line for implementation of a relief plan.

So that we may have an adequate record, the Commission hereby schedules a hearing on the proposed relief plan to be held on **May 27, 2009**, at 2:30 p.m. in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska.
