MOTION TO APPEAR PRO HAC VICE

Black Hills Nebraska Gas Utility Company ("Black Hills"), through its attorneys, submits this Motion for attorney Cameron L. Sabin to appear Pro Hac Vice in the above-captioned proceeding pursuant to Nebraska Rules of Commission Procedure, NEB. ADMIN. CODE, Title 291, Chapter 1, Commission Rule 002.02. In support of this Motion Black Hills states as follows:

1. On September 30, 2015, Black Hills/Nebraska Gas Utility, LLC, d/b/a Black Hills Energy ("Black Hills Nebraska" or the "Company") filed an application seeking an order from the Commission (1) authorizing the Company to enter into a Cost of Service Gas Agreement (the "COSG Agreement") with Black Hills Utility Holdings, Inc. ("BHUH"); (2) approving revised tariff sheets and authorizing the recovery of amounts incurred under the COSG Agreement from customers through the Company's purchased gas adjustment ("PGA") and annual cost adjustment ("ACA") clauses; approving the requested 50% hedge-participation level based on the Company's forecast annual firm gas demand or, in the alternative, a revised percentage that the Commission may determine; and (4) to the extent necessary, granting any waivers from affiliate rules or regulations or ring-fencing commitments, as the Commission deems applicable (the "Application").

2. Black Hills is currently represented by attorney Douglas J. Law, an attorney of good standing in the State of Nebraska (Attorney No. 19436).

3. Black Hills hereby requests that attorney Cameron L. Sabin be admitted pro hac vice in this proceeding so that he can also represent Black Hills.

4. Mr. Sabin is admitted to practice law in the State of Utah and is a member in good standing with the Supreme Court of the State of Utah (Attorney No. 9437).


