AFTER DUE INVESTIGATION, it is hereby certified that the above-named carrier has complied with all applicable provisions of Neb. Rev. Stat., Sections 75-301 to 75-322.04, (Reissue 2003), and the requirements, rules and regulations prescribed thereunder and, therefore, is entitled to receive authority from the Nebraska Public Service Commission to engage in transportation in Nebraska intrastate commerce as a motor carrier.

IT IS CERTIFIED, that pursuant to the Commission's Order the said carrier be, and it is hereby, issued this Certificate of Public Convenience and Necessity as evidence of the authority of the holder to engage in transportation in Nebraska intrastate commerce as a common carrier by motor vehicle; subject, however, to such terms, conditions and limitations as are now, or may hereafter be, attached to the exercise of the privileges granted to the said carrier.

AND IT IS FURTHER CERTIFIED, that the transportation service to be performed by the said carrier in Nebraska intrastate commerce shall be as specified below:

SERVICE AND TERRITORY AUTHORIZED: COMMON: Transportation of passengers and their baggage by limousine between points in Hall County and between points in Hall County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. SUPP. 1: Passengers and their baggage between points in Hamilton, Clay, Adams, Buffalo, Sherman, Howard, Merrick, and York counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. HHS Designation: No. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

SUPPLEMENT 1:

Transportation of passengers by limousine between points in Custer, Dawson, Gosper, Phelps, Kearney, Franklin, and Harlan counties and between points within said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. HHS Designation: No. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

SUPPLEMENT 2:


Transportation of passengers by limousine between points in Furnas, Red Willow, Frontier, Lincoln, Valley, Greeley, Boone, Nance, Polk, Webster, Blaine, Loup, and Garfield counties and between points within said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of Railroad train crews and their baggage is not authorized. HHS Designation: No.

SUPPLEMENT 3:

Transportation of passengers by bus in special party and charter in the state of Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.
